Current hours:

- serve alcohol 11AM to 12AM Sunday through Monday
- entertainment 3PM to 5PM and 9PM to 11PM on Tuesday Thursday, Friday and Saturday; acoustic music outside to 10AM and amplified to 11PM

Proposed Hours:

- serve alcohol 11AM to 1AM Sunday through Monday
- entertainment 11AM to 12AM Sunday through Monday, acoustic music anytime, amplified music Friday, Saturday and Sunday if Monday Holiday

The Board noted that one requirement they have for all alcohol licenses is food must be served when alcohol is being served. Caroline's will provide a late night menu of food options available.

The Public noted that their main concern is the noise especially the drums and amplification. The Board and Caroline's discussed this concern in further detail. Caroline's will look at options to reduce the noise – for example, close the door by the drums, check into buffers for the drums, angle the bands away from the doors.

Based on the discussions, the Board recommended and agreed to:

- Amplified Music to 11PM only on Friday, Saturday and holiday weekend Sundays
- Acoustic Music anytime during the normal hours of operation to 11PM
- Alcohol can be served between 11AM to 1AM with a late night menu

Suzanne Bryan made a motion to approve the Entertainment License for Caroline's Bar & Grill for amplified music Friday, Saturday and holiday weekend Sundays to 11PM and acoustic music any day between 11AM to 11PM

Town Meeting Communication and Web Page:

Kayla Urquhart reviewed the updates to the Web Pages which allows people to see information that is included in the news flashes. The Town Meeting pages were under the Town Clerk section, however that is not intuitive to people to find. This change moves it to the front page.

Vessel Storage and Mooring Regulations

This is informational for the Board to review. The Public Hearing is scheduled for April 24, 2023 and at that time, the Board will vote to approve the revised regulations.

The Board discussed the regulations in further detail. Comments were made in the following areas:

- ADA storage spaces are being increased from 2 to 6 per location
- Moorings 3.11 clarify individual moorings cannot be sublet but marina moorings can be
- Vessels 4.3 need to address areas like Collins Landing which has no storage areas but has moorings

<u>Determination and Consent – Legal Representation for the Towns of Wellfleet and Eastham – 80 State Highway, Maurice Campground Water Connection Inter-Municipal Agreement</u>

Jacqui Beebe clarified the Consent form and confirmed it is a legal ethical requirement for law firms when they are representing 2 entities in the same issue.
